#### APPENDIX 1

#### A. 'better preparing students for admission to the Cypriot Bar if they so wish.'

- 1. The LLB offers optional modules that cover learning materials and professional skills core to the the Cyprus Bar. These are the following: Cyprus Public Law and System, Cyprus Civil and Criminal Procedure, Cyprus Property and Succession Law. These modules are taught by members of staff who have passed the Cyprus Bar exams and/or are experienced practitioners, and can therefore provide students with the appropriate guidance and feedback. The three modules listed above are taught and assessed in English, but significant emphasis is placed on Greek terminology, the Cyprus Bar exams being in the Greek language. Additionally a bilingual glossary of legal terms and a bilingual index of resources have been developed in the context of a module entitled Foundations in English and Cypriot Law.
- 2. On occasion and upon demand, a number of extra-curricular classes are offered, free of charge, to students who are interested in sitting the Cyprus Bar exams in the following areas: Cyprus mooting skills; Cyprus Employment Law; Cyprus Contract Law; Cyprus Criminal Law; Cyprus Law of Torts; Cyprus Family Law and Cyprus Company Law. These extra-curricular modules are not part of the LLB programme as such and are not assessed; they are taught in Greek to familiarise the students with the language of instruction of the Cypriot Bar.
- 3. During the Employability Month (March of every year), different lawyers and representatives of law firms are invited to talk to, network with the students and share their experiences with them (activities predominantly in English). This year's activities include the following:
  - a. 'The NomoPlatform, the idea behind it, and its relationship with policy-making and law commissioning' (Guest Speaker: Dr. Nicolas Kyriakides, Partner and Head of the Banking & Finance and Insurance Law Departments at Harris Kyriakides LLC);
  - b. 'What is it like to be a Trainee at the Court of Justice of European Union?' (Guest Speaker: Mrs Stamatina Stergiou, PhD candidate at the University of Cyprus and LLM Alumna of UCLan Cyprus);
  - c. LLB alumni discussed their experience regarding employment after graduation and job opportunities in the UK (LPC for Alexandros Theocharous, Bar course for Denys Georgiou);
  - d. Cyprus Police: Career Opportunities (Guest Speaker: Mr Mamas Evaggelou (LLM alumnus) on behalf of Cyprus Police);
  - e. Sovereign Base Areas: Career Opportunities (Guest Speaker: Superintendent Dinos Petrou (MBA alumnus));

# C. Mechanisms, processes and infrastructures on the needs of a diverse student population including mature, part-time, employed and international students as well as students with disabilities

With regards to **disability**, at the time of their university application and as part of the enrolment procedure, students are asked to declare any special circumstances, learning difficulties and disabilities they are facing for which they may need support and special arrangements throughout their studies. Once learning or other difficulties are declared, the student support will request supporting documents and any past reports they may have, from previous studies justifying any provisions. Once the report is reviewed, it is signed by both the student support officer and student. The admission officer assigned as 'admin advisor' to the student is then informed and proceeds with finalising their application and enrolment. The Course Leader is then informed in confidence, so appropriate actions are taken both in class and during exams. Students may also declare a disability/learning difficulty during their studies. The procedure remains the same. Disclosing disability: https://www.uclan.ac.uk/students/cyprus/support/health/disability.php The approved provisions vary, and are tailored to each student's case and circumstances; they usually include taking exams in a separate examination room from their fellow classmates, are given extra time during exams, are allowed memory aids during tests or simplification of questions and instructions etc.

Regarding **diversity**, throughout the academic year, the student support services in collaboration with the Administration office and Course Leaders, monitors student attendance, wellbeing and academic performance in order to capture any students who may be dealing with either academic or personal issues. All students, whether on or off campus due to the pandemic, are assigned an academic advisor, who is the first person of contact when academic support is needed. Course Leaders, also involved in the monitoring of each student's performance, capture 'weak' or 'at risk' students. 1-to-1 meetings with the students are conducted throughout the year, and there is close monitoring for students who have been 'flagged'.

Students' **wellbeing** and engagement with the University's faculty and other classmates are very important to us; therefore, the University's Student Council under the direction and support of the appointed student support officer, aims to foster, develop and increase students' social awareness; help new students adapt easily to the academic environment and the student life in general; create a multi-cultural environment of acceptance and understanding; enable the communication of ideas, complaints and suggestions by the students to the responsible departments or relevant bodies to ensure that the student voice is heard. The Student Council itself, as the official representative student body, aims to create an environment in which all students feel welcome regardless of ethnicity, race, religion, gender, age, disabilities, sexual orientation, financial background and social class.

International students/Immigration: the procedure for a student visa begins with the registration, at the Admissions office, before the student arrives in Cyprus. Once he/she arrives, the appointed student support officer will guide the student in person for the steps needed be taken. The information online to is also available https://www.uclan.ac.uk/students/cyprus/support/international/immigration.php All students, both international and EU/locals, are sent a 'Welcome Pack / Email' on behalf of



the student support services, giving them all important information on life in Cyprus, immigration matters, life on campus, means of transportation, accommodation, useful contacts etc.

**Support**: The UCLan Cyprus Psychological Wellbeing and Counselling Centre provides professional services and support to all UCLan Cyprus students. The services offered include individual psychological sessions, group therapies, psychometric assessments. Within a safe and caring environment, our counsellors can provide support to students who are dealing with academic and/or personal challenges, low self-esteem or self-confidence; lack of motivation to attend lectures; low academic performance; stress and anxiety; depression; grief; interpersonal or social problems. In order to safeguard confidentiality issues, students are invited to arrange an appointment directly with the Psychological Wellbeing and Counselling Centre.
