Response to the CYQAA Preliminary review of "LLM International Business and Law", which is going to be offered by the Alexander College (Paphos), via the franchise method, in collaboration with the Canterbury Christ Church University, UK

We would like to express our sincere appreciation to the CYQAA for the cooperation of both parties towards the completion of this review of information in accordance to Articles 10, 11 of the relevant law. In response to the CYQAA preliminary report (20th June 2024) and specifically to the observations and request for further information for the LLM International Business and Law – (180 Credits, 90 ECTS, 1 Year Duration), Paphos campus, please consider the following points:

Qualifications and Employment relationship

• The aim of this LLM is to equip students with a critical and open mind approach towards the Law while at the same time provide insights into the practical aspects of the legal professions. We combine traditional scholarly attributes with more practice-led skills, so that at the end of the programme, students are qualified to work in multiple sectors. Having this in mind, all of the staff is approved and continuously trained by the CCCU University as ANNEX X "Approval of Delivery Letter" by the CCCU University, clearly specifies.²

Moreover, CCCU defines the minimum required qualifications of the teaching staff as per the following: "We expect teaching staff at the partner to possess the relevant teaching experience in relation to Higher Education together with Practitioner experience. All tutors teaching on our courses must submit their CVs to the University and subject to approval

Training of the Alexander College teaching staff is mandatory and continuous.³ Moreover, the academic staff of Alexander College and CCCU, take part in a monthly meeting to discuss and support any academic issues. Alexander College chairs three Board of Studies (BoS) meetings per academic year. BoSs comprise of the Alexander College academic staff, CCCU ALT, Director of Partnership, IPAD International Partnerships Manager/IPO. The CCIP⁴ is informed by module feedback, student/staff liaison meetings and the External Examiner Report. Therefore, the teaching staff is actively engaged (and trained) in the successful running of the Programme.

• To develop both knowledge and skills to support students' entry and progression into employment as confident legal professionals, we indeed recruit a combination of PhD academics (four for LLM Paphos) and some exemplary and enthusiastic non-PhD legal practitioners, all of whom holders of an LLM (four out of eight for LLM Larnaca). The latter group consists of one lecturer (please see Table A, A/A: 8) who holds PG Cert in Learning and Teaching (in Higher Education), LLM, LLB and is an approved trainer of HRDA. The second non-PhD (Table A, A/A: 6) is a research assistant with a book publication (Routledge Publications), holder of LLM, LLB and six years of teaching experience. The next lecturer (Table A, A/A: 5), LLM (International Economic Law with Distinction, a qualification which explicitly matches with the profile of the Programme), LLB holder is an experienced advocate/legal consultant, owner of Law firm, successfully providing legal services to public entities. He has eight years of teaching experience. Lastly, lecturer (Table A, A/A:2) is a senior lawyer (LLM, LLB) in litigation and private client dept of a large company, with eight years of teaching experience, a profile which fits to the purpose of the proposed LLM in International Business and Law.

- To collaborate with qualified legal practitioners and/or experts in their respective field is an important commitment to enhance student experience and offer to the students the key transferable skills for their journey in real life. We suggest that this practise is followed, as evidenced, by many HEI, Universities and Colleges, especially in the field of Law, both abroad and in Cyprus. We separately attach a list of Universities in Cyprus which share the same aspiration, as a sample of our contribution to the debate. The aforementioned Universities in Cyprus, employ a significant number of qualified in the subject and practice -non-PhD holders and PhD holders collaborating at a part time basis. We suggest that this practice is widespread in all Law Schools of both Public and Private Universities offering postgraduate studies.
- Further to the above, and in conformity to the spirit of the relevant CYQAA observations and further information requested, we will take the following measures should this request for review is completed:

We further enhance the ratio of both PhD qualified personnel and full-time staff

- 1. one member of the current teaching staff (please see Table A, A/A: 8.) will be employed on a full-time basis (as of Fall Semester 2024).
- 2. A PhD member of the current staff (please see Table A, A/A: 7, Assist. Prof.) will also be employed on a full-time basis (as of Fall Semester 2024).
- Alexander College continuously supports the enhancement of professional and academic development of the teaching staff. Alexander College Law sector was awarded the Gold Award at the Cyprus Education Leaders Awards (2022) for Best Learning Experience for the project "MootCourtSkillS@EmpowerMent#Simulation- Εικονικό Δικαστήριο" (https://paideia-news.com/alexander-college/2023/04/03/simantikes-diakriseis-sta-cela-2022-gia-to-alexander-college-kai-to-ereynitiko-kentro-alexander/).
