This Final Report was prepared on the basis of Article (20) (2)(f)(i) of the "Quality Assurance and Accreditation in Higher Education and the Establishment and Operation of an Agency on Related Matters Laws" of 2015 to (No. 2) 2020 [N.136 (I)/2015 to 138(I)/2020].

THE PROCEDURE:

On 31 July 2019, the legal representative of the Higher Education Institution University of Central Lancashire Cyprus submitted an application (Doc. 200.3), based on Article (17) of the "Quality Assurance and Accreditation in Higher Education and the Establishment and Operation of an Agency on Related Matters Laws" of 2015 to (No. 2) 2020, for the evaluation-accreditation of the Department:

This application is registered in the file with the reference number: 07.14.341.001

In the framework of competences conferred on it by the relevant legislation, the Council of the Agency has constituted an External Evaluation Committee (EEC) which, after initially examining the Department's application for evaluation and accreditation, performed a remote visit at the

institution on 1st February 2021. During the remote visit the EEC also evaluated the following programmes of study that belong to the Department (Only for currently operating Departments):

The EEC met remotely with the head of the institution, the head of the Department, the programmes' coordinators, members of the academic staff, and members of the administrative staff, students and/or their representatives and the Internal Quality Assurance Committee.

Additionally, the EEC examined remotely the Department's facilities (library, computer labs, labs, teaching classes, research infrastructures, etc.), various documents presented and/or requested by the EEC, the School's/ Faculty's structure and the Department's position in it, the CVs of the teaching staff and their relationship to the institution as teachers in regard to any other duties and teaching in other programmes of study.

The EEC has documented its findings and recommendations and drew up the External Evaluation Report in the Doc. 300.3.1.

CYQAA Council's Decision

The Council of the Cyprus Agency of Quality Assurance and Accreditation of Higher Education, during its 66th Summit on 11th and 12th May 2021, on the basis of Article 20 (2)(f) (i) of the "Quality Assurance and Accreditation in Higher Education and the Establishment and Operation of an Agency on Related Matters Laws" of 2015 to (No. 2) 2020 [N.136 (I)/2015 to 138(I)/2020], and on the basis of the suggestions of the External Evaluation Committee and the comments of the institution on the report, **decided that the Name of the Department is accredited.**



The current accreditation begins in the Winter semester of the academic year 2021- 22 and ceases to be in effect at the end of the Spring semester of the academic year 2025 – 26.

On the basis of Article (4) of the relevant Legislation, it is noted that "the above accreditation is valid for the period provided by the provisions of the Law and is repeated every five (5) years and that the procedure starts at the request of the institution which must, and shall be submitted at least sixteen (16) months before the expiry of the previous accreditation".

Additionally, on the basis of Article (17) (3) (f) during the period of validity of the Accreditation, the Agency acting of its own motion, may examine whether the criteria continue to be met and if they are not met, then the Agency shall revoke the Accreditation, and immediately inform the institution concerned.
