This Final Report was prepared based on the Article (20)(2)(f)(i) of the "Quality Assurance and Accreditation in Higher Education and the Establishment and Operation of an Agency on Related Matters Laws" of 2015 to 2021 [L. 136 (I)/2015 - L. 132(I)/2021].

THE PROCEDURE:

On 11 September 2025, the legal representative of the Higher Education Institution Cyprus College Nicosia, applied (Doc. 200.2), based on Article (17) of the "Quality Assurance and Accreditation in Higher Education and the Establishment and Operation of an Agency on Related Matters Laws" of 2015 to 2021, for the evaluation-accreditation of the Institution with name:

IN GREEK: Cyprus College, Λευκωσία

IN ENGLISH: Cyprus College, Nicosia

This application is registered with the reference number: **07.14.033**

In the framework of the competences conferred upon it by the relevant legislation, the Council of the Agency has constituted an External Evaluation Committee (EEC), consisting of three (3 academics, one expert in student welfare issues, one expert in matters of building and technological infrastructure, and one university student. The EEC after initially examining the Institution's application for evaluation and accreditation, performed an on-site visit at the institution on 8 October 2025.

The EEC met with the head of the institution, the heads of the departments, the programmes' coordinators, members of the academic staff, and members of the administrative staff, students and/or their representatives and the Internal Quality Assurance Committee.

Additionally, it reviewed the Institution's facilities (library, computer rooms, laboratories, classrooms, research infrastructure, etc.), the institution's academic profile and orientation, quality assurance system and strategy, administrative structures, curriculum planning processes and the organization of teaching, the suitability of the academic and teaching staff and the research support mechanisms as well as various other documents presented to it and/or requested by the ECC.

The EEC has documented its findings and recommendations and drew up the External Evaluation Report in the Doc. 300.2.1.

CYQAA Council's Decision

The Council of the Cyprus Agency of Quality Assurance and Accreditation of Higher Education, during its 129th Summit on 15 December 2025, on the basis of Article (20)(2)(f)(i) of the "Quality Assurance and Accreditation in Higher Education and the Establishment and Operation of an Agency on Related Matters Laws" of 2015 to 2021 [L. 136 (I)/2015 - L. 132(I)/2021], and on the basis of the suggestions of the External Evaluation Committee, and the comments of the institution on the External Evaluation Committee report, decided that the Institution is accredited as: Private Institution of Higher Education, with the following recommendations:

The institution should ensure that, by the next evaluation:

- Should **increase** the number of the permanent **full time staff members**, in combination with a reduction in their teaching hours and their overall workload.
- Should **invest** in cutting-edge infrastructure to support **modern educational technologies** and further enhance the quality of the educational environment.
- An annual interdisciplinary stakeholders' meeting should be established to foster synergies, programme coherence and the overall alignment of operational goals with the programme's design. All contributions and resulting changes should be systematically recorded in a structured table.
- It is further recommended that the institution's **policy planning**, **implementation**, **and monitoring mechanisms** are **enhanced**, specifically in terms of staff personal development, research activities, and regulations on the use of artificial intelligence.

The current accreditation begins in the Fall semester of the academic year 2025 – 2026 and ceases to be in effect at the end of the Spring semester of the academic year 2029 – 2030.

On the basis of Article (4) (c) of the relevant Law, it is noted that "the above accreditation is valid for the period provided by the provisions of the Law and is repeated every five (5) years and that the procedure starts at the request of the institution which must, and shall be submitted at least sixteen (16) months before the expiry of the previous accreditation".

Additionally, on the basis of Article (17)(3)(g) during the period of validity of the Accreditation, the Agency acting of its own motion, may examine whether the criteria continue to be met and if they are not met, then the Agency shall revoke the Accreditation, and immediately inform the institution concerned.
