# **1.** Study programme and study programme's design and development *(ESG 1.1, 1.2, 1.8, 1.9)*

We would like to thank the committee for their very encouraging comments. The committee's findings underline the thorough feasibility study, the way the programme was developed and its positioning in the other programmes of study that City Unity College Nicosia offers as well as the market as a whole.

# Strengths:

We are very appreciative of the committee's comments which focus on the "broad number of qualified faculty members" teaching in the programme as well as the clarity of the programme structure and the content.

## Areas of improvement and recommendations:

On preparing the programme we have made sure to include the latest publication textbooks as well as publications drawn from International Organisations such as the WTO and the WCO, the United Nations, the European Commission and Cyprus government publications.

We also would like to point out that our Institution's policy and practice in place, is that at the end of each academic year, lecturers are required to assess the need to renew the textbooks and other academic material used, and suggest the updating of the relevant publications, this process is also moderated as part of the course review process at the start and end of the semester as highlighted in the Assessment and Moderation Policy. Therefore, we fully agree and already comply with the EEC's recommendation.



# 2. Teaching, learning and student assessment (ESG 1.3)

## Findings:

The EEC had the opportunity to converse with module leaders regarding the content of the programme. We would like to point that the committee has fully understood and endorsed the mission of the programme as well as the need to incorporate both practical and theoretical elements into the learning and teaching. This is our philosophy at City Unity College Nicosia which was fully appreciated by the EEC. We would like to thank them for their encouraging and fully positive feedback.

## Strengths:

The ethos and mutual respect between students and faculty members at City Unity College Nicosia was recognised by the EEC, as it was evident from the interviews conducted with the faculty members, students and members of the administration. We would also like to point out that the EEC has appreciated the experience that CUC Nicosia has in offering programmes at the Master's level stemming from the ongoing collaboration of the College with Cardiff Metropolitan University. The positive comments of the EEC are fully appreciated and well noted.

## Areas for Improvement and recommendations:

The EEC commented on whether the criteria for and methods of assessment are published and available to the students in advance. Due to the limited time as well as constraints that arise from an online accreditation visit, we did not have the chance to demonstrate our online learning platform called eClass (Moodle based platform), where all criteria and methods of assessment are published in advance, one week before the beginning of the semester.

We would like also to point out that even before the necessities imposed by the pandemic, all lecturers were using our eClass platform to upload course outlines, syllabuses, notes and other lecturing material, as well as assessment material. The platform is also used as a communication tool whereby academic staff can connect and interact with students throughout their courses.
