



Introduction

We would like to sincerely thank each member of the External Evaluation Committee (EEC) for taking the time to review, evaluate and provide their valuable experience and insights for the BSc program of Sports Science of the University of Nicosia. We feel privileged to have received such positive comments by the EEC and having had constructive discussions with its members.

In summary, the EEC found the programme of Sports Science of the University of Nicosia to have well developed structure with scientifically sound course content, well developed teaching methods with high level laboratory teaching, staff with international research profile, strong student support with clear entry criteria and strategies to support students who have difficulties in meeting formal criteria, as well as high standard of teaching and learning resources, physical resources, human support resources as well as student support, at a higher level than what can be expected from a European standard.

The EEC has also identified certain areas for improvement and we welcome those comments and we aim to implement them as they shall make our program even stronger. Please find below the detailed responses to the EEC's recommendations.



1. Study programme and study programme's design and development (ESG 1.1, 1.2, 1.7, 1.8, 1.9)

Findings by the EEC:

• "The bachelor of sports program is well developed".



2. Student – centred learning, teaching and assessment

(ESG 1.3)

Findings by the EEC:

• "The style of teaching and the teaching methods are well developed".

The faculty member had all studied and/or worked abroad, in different countries and universities. The knowledge and experience acquired was brought back to Cyprus, and everyone strived for the benefit of the Sports Science program. Again, we thank the committee for their positive comment.

Strengths:

• "Students praise that their teachers are easily approachable to discuss difficulties and provide straightforward help".

Faculty members early recognized the need to be close to the students. We are happy to see that the students recognize this and that our effort to create a positive environment for the students has paid out. We are also pleased that the EEC has positively noticed it.

• "Students can gain experience with laboratory-based performance testing while still in the undergraduate program".

Having a hands-on practical laboratory experience was considered important from the very beginning. We have found it to be an important element of our program and we are pleased that you have identified this as one of our strengths.

The evaluations are activated once 75% of the semester is completed and deactivated one day before the beginning of the examination period. The results are released 21 days after the end of the examination period. 3. Teaching staff

(ESG 1.5) Findings by the EEC:

• Teaching staff recruitment and development "Recruitment and development appeared well functioning for permanent staff. Part time staff seemed well qualified but development possibilities appeared limited".

We agree with the committee's comment on part-time staff, and discussions on this matter have been taken to the School level, in order to prepare suggestions to the University.

Teaching staff number and status
"The education is very much based on part-time employees which is a risk for continuity, development and research based teaching".

We appreciate the committee's comment and concern. Indeed, this is a very reasonable thinking, but we must also note that the vast majority of the part-time staff have been teaching here for a decade, and we do not anticipate any change in staff in the near future.

• Synergies of teaching and research B.Sc. students are given the opportunity to see and be introduced to the professor's labwork for research. We consider this to be good practice.

We would like to thank the committee for the positive comment. Being a relatively small program, compared to the programs of other major universities abroad, gives us the time, space and availability to work closely even with BSc students.

Strengths:

- All permanent staff had international research profiles.
- Some part time staff had international research profiles whereas others were more national oriented.

It has to be noted that many of our part-time staff are PhD holders with teaching and research experience both in Cyprus and abroad. These lecturers can work independently and offer high quality teaching and research. Contrary to other universities abroad, our part-time staff has knowledge and experience equivalent to the full-time staff.



A way should be found to allow teachers to fail very underperforming students in the program without having to spend a great many hours on individual support before.	Teachers have been failing underperforming students. Passing mark is 60% at the University of Nicosia and students must have a 2.0/4.0 CPA in order to graduate. Those who do not manage to get a passing mark of 60% can sit a second exam in September in order to pass the course. If they still fail, the students have to re-take the entire module. The university also has specific cut-off lines and students who do not meet that standard are placed on probation. With regards to individual support the university's students' office can provide free tutorials for those students. The instructor can advise the students but the professor is not obliged to spend hours on end for each failing student. We do acknowledge that some teachers	Choose an item.







The panel has been convinced that the evaluated programmes offered by the University of Nicosia were of the highest standards in Cyprus based on the feedback from professors, management, students and external stakeholders to the University. The educational programmes evaluated were of a standard commensurate with other European programmes that the panel is familiar with. However, we strongly encourage that the University invests in research support services. What is clear from the evolution of the most successful universities worldwide is that researcher independence and excellence in research provides the basis for excellence in teaching and education. Whilst investment is required this will have a positive impact on other University KPIs. Investment in research not only increases the quality of the University. Investments can also be expected to provide economic return in the form of more and larger grants with overhead as well as increased international recognition followed by elevated student application rates (and further success in international University rankings not the least). It should be noted by the University of Nicosia that the EU funds for research in 2023-2024 is 13.5 billion EUR. Several of the EU research topics are relevant for researchers in the evaluated programs.
