## **RESPONSE**

The Bachelor's degree of Accounting and Finance is offered under the Department of Business and Management of UCLan Cyprus. The following programmes of study are currently provided under this department:

Business Administration [1 academic year, 90 ECTS, MBA]



Business Administration [1 academic year, 90 ECTS, MBA, e-learning]

Hospitality, Tourism and Events Management [1 academic year, 90 ECTS, MA]

Human Resources Management [1 academic year, 90 ECTS, MSc]

## **RESPONSE**

Academic staff at UCLan Cyprus engage in a variety of professional development activities that support their teaching, research, and academic leadership. These include participation in both internal and external training events.

Academic staff from the team frequently attend international conferences such as FMARC, FMA-European, MFS, EAA, EFMA, which offer opportunities for research dissemination, networking, and staying up-to-date in their fields.

The University also encourages and supports faculty to pursue professional teaching qualifications such as the Fellowship of the Higher Education Academy (FHEA), which promotes high standards in higher education teaching and learning.

Internally, UCLan Cyprus hosts and participates in seminars and conferences aimed at enhancing academic skills. Please find below some examples of seminars undertaken by the programme team:

It is also worth mentioning the forthcoming Cyprus Statistical Society Conference, featuring a FENStatS session on statistical literacy, that is co-organized with international partners such as the Royal Statistical Society. This conference will take place on Friday 30 May, 2025, at UCLan Cyprus and is aiming to enhance statistical literacy and data-driven analytical skills among academics, which are essential competencies for both teaching and research in Accounting and Finance.

Research support is offered through a dedicated office that provides training and guidance on funding applications assisting at the same time academic staff in identifying research funding opportunities and developing competitive proposals. For example, it organises a series of



Erasmus+ project development workshops aiming at equipping academics with the skills to create and submit their own Erasmus+ proposals. These workshops are held periodically and cover the full project development cycle—from idea formulation and partner identification to budgeting and application best practices. Accounting and Finance academic staff also benefit from participation in external seminars organized by institutions such as the Central Bank of Cyprus, the Ministry of Finance, and other universities. Notable events include conferences on financial literacy, economic policy, and leadership and gender in higher education.

✓ The EEC recommends the programme to explore the idea of assigning a "research assistant/advisor" to strengthen the "single research project". The research assistant role could help pairing up different professors/researchers for guidance and exchange (relevant for e.g. identification of potential PhD students).

We appreciate the EEC's recommendation regarding the enhancement of the research environment of the team, which leads to the strengthening of the provision of the "Single Research Project" module offered by the programme, through the potential introduction of a "research assistant/advisor" role. We fully acknowledge the importance of this addition in supporting the delivery of high-quality student research.

In fact, assigning an advisor or assistant that is paired with the specific research topic of the student/young researcher is already a practice that we value and practise. To this effect, at the beginning of each academic year, advisors are selected according to their expertise and are aligned with the students' research topic and interests, ensuring that both the academic quidance and research direction are well-matched. This approach not only strengthens the supervision process, but also promotes interdisciplinary collaboration and may facilitate the early identification of students with a potential to pursue a PhD. We view this recommendation as an opportunity to further structure and enhance this process and will explore ways to integrate further within the module's framework.

✓ The EEC invites the institution to consider summer internship programmes for 3rd and 4th year students to increase exposure to industry and to strengthen and intensify industry collaboration.

We appreciate the EEC's recommendation to consider summer internship programmes for 3rd and 4th year students to enhance industry exposure and strengthen industry collaboration. This is an area of great importance for UCLan Cyprus. As part of their programme of study, the students have the opportunity to choose the placement modules "Work Based Learning Project" in Year 3 as well as the "Work Placement" module during the Sandwich year (after Year 3). Furthermore, the students are offered, every year, during the Summer Semester, training opportunities through the Erasmus + scheme at related institutions and companies based in European Union.

Furthermore, the Department of Business and Management of UCLan Cyprus has established a strong industry network offering students ample opportunities for internships and graduate employment through activities such as a) the Career Day events-where more than ten leading accounting firms visit our campus—and b) through the "Introduction to Personal and Professional Practice" module, where companies review year two students' presentations and offer internships to promising candidates that, upon students' performance at the offered internship, can mature into contracts of full-time employment upon graduation.

Additionally, key Memorandums of Understanding with ACCA, KPMG, and Grant Thornton provide not only summer internships, but also a one-year paid internship option between the 3rd and 4th years. This extended internship supports students by offering practical work experience and financial support for ACCA papers not covered by our regular exemptions.



These initiatives clearly show our commitment to enhancing industry exposure and strengthening our ties with leading companies.
