EEC's final recommendations and comments on the HEI's response

The College's responses to most of the issues raised by the EEC, such as those about the quality assurance policy, moderation, feedback and the selection process for the student representatives in the quality assurance committee, are satisfactory. In the long term, the College may want to consider a more formal and coherent plan for better moderation and feedback. In particular, the EEC acknowledges the Quality Assurance policy provided in Annex 1. The EEC is pleased to note the changes made to address some specific aspects, such as student representatives election and the revision of the syllabus of some courses. Overall the response and the introduced changes fully address the committee's recommendations.



2. Student - centred learning, teaching and assessment (ESG 1.3)

EEC's final recommendations and comments on the HEI's response

The EEC notes that a plan for a continuous monitoring and integration of best practices in teaching and corresponding faculty training has been incorporated. The EEC acknowledges the fact that oral feedback has always been given to students and that a Student Feedback policy has been introduced. Overall the response and the introduced changes fully address the committee's recommendations.



3. Teaching staff (ESG 1.5)

EEC's final recommendations and comments on the HEI's response

The EEC notes that the College policy and documentation on faculty performance appraisal and promotion have been revised. The EEC particularly appreciates the introduction of a compulsory training session for faculty members in pedagogy. The EEC acknowledges the Internal Funded Policy (Annex 19) and that faculty engaging in research may be entitled to a reduction in teaching workload. It is noted that the College's policy for faculty performance appraisal and promotion has been revised in this direction. It is also noted that some research outputs are distributed to students. Overall the response and the introduced changes fully address the committee's recommendations.



4. Student admission, progression, recognition and certification (ESG 1.4)

EEC's final recommendations and comments on the HEI's response

Thanks to the response the EEC better understands the extent of the use of the English language in the courses and the related admission requirement. The plan for advertising and promotion of the program is praised. The EEC notes the revision of the process for exam retake. Overall the response and the introduced changes fully address the committee's recommendations.
