THE PROCEDURE:

On 31/03/2020, the legal representative of the Higher Education Institution Frederick University submitted an application (Doc. 200.1), based on Article (17) of the "Quality Assurance and Accreditation in Higher Education and the Establishment and Operation of an Agency on Related Matters Laws" of 2015 to 2020, for the evaluation-accreditation of the programme of study:

In the framework of competences conferred on it by the relevant legislation, the Council of the Agency has constituted an External Evaluation Committee (EEC) which, after initially examining the institution's application for programme evaluation and accreditation, performed a remote visit at the institution on the 2nd and 3rd of March 2021.

The EEC met remotely with the head of the institution, the head of the relevant department, the programme's coordinator, members of the academic staff, members of the administrative staff, students and/or their representatives and the Internal Quality Assurance Committee.

The EEC has documented its findings and recommendations and drew up the External Evaluation Report in the Doc. 300.1.1.

The Council of the Cyprus Agency of Quality Assurance and Accreditation of Higher Education, during its 71st Summit on 13th September 2021, on the basis of Article (20)(2)(f)(i) of the "Quality Assurance and Accreditation in Higher Education and the Establishment and Operation of an Agency on Related Matters Laws" of 2015 to (Num. 3) of 2020 [N.136 (I)/2015 to N.208 (I)/2020], and on the basis of the suggestions of the External Evaluation Committee and the comments of the institution on the External Evaluation Committee report, **decided that the programme is accredited to be delivered in English.**

On the basis of the recommendations of the EEC, the institution should provide evidence of compliance with the following remarks, no later than the submission of the application for reaccreditation:

- i. Create conditions to enhance research culture among faculty members.
- ii. Address the issue of aging faculty members. Recruitment of new staff should be scheduled within the current academic year (2021-2022).
- iii. Improve the interactivity of the weekly based e-learning activities.

The current accreditation begins in the Fall semester of the academic year 2021-2-2022 and ceases to be in effect at the end of the Spring semester of the academic year 2025-2026.

On the basis of Article (4) of the relevant Legislation, it is noted that "the above accreditation is valid for the period provided by the provisions of the Law and is repeated every five (5) years and that the procedure starts at the request of the institution which must, and shall be submitted at least sixteen (16) months before the expiry of the previous accreditation".

Additionally, on the basis of Article (17)(3)(f) during the period of validity of the Accreditation, the Agency acting of its own motion, may examine whether the criteria continue to be met and if they are not met, then the Agency shall revoke the Accreditation, and immediately inform the institution concerned.
