This Final Report was prepared on the basis of Article (20) (2)(f) (i) of the "Quality Assurance and Accreditation in Higher Education and the Establishment and Operation of an Agency on Related Matters Laws" of 2015 and 2020 [N. 136(I)/2015 – 138(I)/2020].

THE PROCEDURE:

On the 13^{th} of January 2023, the legal representative of the Higher Education Institution College of Business Studies (CBS) submitted an application (Doc. 200.1), based on Article (17) of the "Quality Assurance and Accreditation in Higher Education and the Establishment and Operation of an Agency on Related Matters Laws" of 2015 and 2020 [N.136(I)/2015 – 138(I)/2020], for the evaluation-accreditation of the program of study:

IN GREEK: Διοίκηση Επιχειρήσεων (4 έτη, 240 ECTS, Πτυχίο)

IN ENGLISH: Business Administration (4 years/240 ECTS, BSc)

This application is registered in the file with the reference number: 07.14.426.004.001

In the framework of competences conferred on it by the relevant legislation, the Council of the Agency has constituted an External Evaluation Committee (EEC) which, after initially examining the institution's application for program evaluation and accreditation, performed an onsite visit at the institution on 8th May 2023.

The EEC met with the head of the institution, the head of the relevant department, the program's coordinator, members of the academic staff, members of the administrative staff, students and/ or their representatives and the Internal Quality Assurance Committee.

Additionally, the EEC examined the institution's facilities (library, computer labs, research infrastructures, etc.), various documents presented and/or requested by the EEC, the School's/Faculty's structure and the program's position in it, the CVs of the teaching staff and their relationship to the institution as teachers in regard to any other duties and teaching in other programs of study.





The EEC has documented its findings and recommendations and drew up the External Evaluation Report in the Doc. 300.1.1.

CYQAA Council's Decision

The Council of the Cyprus Agency of Quality Assurance and Accreditation of Higher Education, during its 97th Summit on 11th of September 2023, on the basis of Article 20 (2)(f)(i) of the "Quality Assurance and Accreditation in Higher Education and the Establishment and Operation of an Agency on Related Matters Laws" of of 2015 and 2020 [N.136(I)/2015 – 138(I)/2020], and on the basis of the suggestions of the External Evaluation Committee, the comments of the institution on the report decided that the program is accredited to be delivered in Greek and in English.

Based on the recommendations of the EEC the institution should provide evidence, of compliance with the following remark, no later than the beginning of the Fall semester 2024-2025.

- i. Members of the teaching team should be actively engaged in relevant research activities which can inform teaching.
- ii. The Research Centre initiative should be supported, and more members of staff should be encouraged to actively participate.
- iii. Staff members are also urged to be more engaged in research and try to publish their work in listed quality academic journals

The current accreditation begins in the **Spring** semester of the academic year **2023 – 2024** and ceases to be in effect at the end of the **Fall** semester of the academic year **2028 – 2029**.

On the basis of Article (4) of the relevant Legislation, it is noted that "the above accreditation is valid for the period provided by the provisions of the Law and is repeated every five (5) years and that the procedure starts at the request of the institution which must, and shall be submitted at least sixteen (16) months before the expiry of the previous accreditation".

Additionally, on the basis of Article (17) (3) (f) during the period of validity of the Accreditation, the Agency acting of its own motion, may examine whether the criteria continue to be met and if they are not met, then the Agency shall revoke the Accreditation, and immediately inform the institution concerned.
