Note: The Open University of Cyprus, as part of its participation in the European Project "University Liaison Offices with the Labour Market," offers students of all its study programmes the optional and free module "[Industry Placement](#)" (BEC495 and BEC696). This unit aims to provide students with professional experience in their field of study through placement in a host organisation (e.g., private businesses, non-profit organisations). Placements can be either full-time or part-time and last for at least 1 month and 150 hours. Each student is entitled to participate in two placements, which must take place in different academic semesters and at different host organisations. Each student placement carries 5 ECTS credits but does not count towards the student's overall grade point average or workload requirements for successfully completing the programme.
